The project is currently approved to conduct a survey of training participants. Most of the survey data is quantitative.

2. Proposed Change:

This change would involve collecting qualitative data during the trainings about the participants' views about general mediation issues. A member of the court staff sponsoring the training would take notes of participants' comments on my laptop computer. The notes will not contain anyone's name or identifying information. The court programs will not retain a copy of the notes.

(I will distribute hard copies of the survey at the training for people who did not complete the survey online. The content of the on-site survey is exactly the same as the online survey.)

3. Justification for the Change:

This is to collect data in addition to the survey, the content of which is not being changed.

5. Requested Amendment

1. If the requested changes will impact the risks or benefits, please explain and provide a description of what process(es) will be put in place to protect the subjects.

This will not affect the risks or benefits. The survey will proceed as originally planned (and now including administration on-site as well as online). The real change in this amendment is to add a qualitative data component. During parts of the training, I will conduct it similar to a focus group using a semi-structured format of open questions. Notes of the responses will not include subjects' names or other identifying information, so there will be no risk to anyone who chooses to respond to the questions. All training participants will receive a summary of the data from this project, regardless of whether they provide responses to the questions.

At the beginning of each training, participants will be given an informed consent form. In addition, I will orally review the key points using powerpoint slides.
